
## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

## History of original corner establishment:

Corner established by Alonzo Gesner under GLO contract No. 683 and dated June 7, 1898.

Surveyor General records state: Set fir post 4' long 4" square 24" in ground for closing Cor to Townships 2 & 3 SR41E mkd CCR41E on E, T2SS31 on N and T3SSE on S faces with 6

groves on NE and S sides from which:
Pine 9" dia brs N65°E, 15 lks dist mkd T2SR41ES31 BT.
Pine 6" dia brs S73°E, 26 lks dist mkd T3SR41ES6 BT.




## Description of corner evidence found:

Rotten post remains to a depth of 18" from which:

A L.P. pine snag 12" dia brs N70 $\frac{1}{2}$ °E,9.9'(record,N65°E,15 lks) marked "CCT2SR41ES31 BT" on open blaze. A L.P. pine snag 7" dia brs S68 $\frac{1}{2}$ °E,17.2'(record,S73°E,26 lks)

with fragmentary scribes on open and rotting blaze.



## Description of monument and accessories I established to perpetuate the original location of this corner:

At position of found rotten wood post...

Set  $2\frac{1}{2}$ " aluminum cap on 2" aluminum pipe 25" in ground with 5" projecting out of ground with surrounding rock mound and 6' fence post alongside with sign 54-9 attached. Cap marked as shown in corner diagram.

New bearing trees established: A spurce 8" dia brs  $N69^{\circ}$ E, 22.2' dist mkd T2SR41ES31CC BT. A L.P. pine 8" dia brs S54 $^{\circ}$ E, 11.5' dist mkd T3SR41ES6CC BT.

Each BT has a sign 54-3 and signs 54-4 or 54-9 attached below a 6" band of red paint, and each new BT has a brass washer marked PLS 1639 nailed flush with BT blaze.

Compass declination 190 East.
