
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner originally established by Alonzo Gesner under GLO contract number 683 dated June 7, 1898. Surveyor General record states: Set baselt stone 28x15x5 ins for cor to secs 19,20,29 and 30 from which;

A yellow pine 32 in diam bears N32°30'E 160 lks dist A yellow pine 34 in diam bears S37°E 110 lks dist A yellow pine 24 in diam bears S88°45'W 80 lks dist A yellow pine 36 in diam bears N26°30'W 128 lks dist



No record of subsequent monumentation found in county records

Description of corner evidence found:

Found a 46 inch diameter P.Pine live and vigorous with blaze evident N32 2 92.8 feet (record distance 105.6 feet)

Found a stump with scribes visible \$88045'W 80 1ks

Found a rotted stump hole N26120W 79.2 feet (record distance 84.48 feet)

This corner falls on a steep hillside and it appears that Mr. Gesner used slope distances to the BTs

Description of monument and accessories I established to perpetuate the

original location of this corner: At record bearings from the found BTs and at record distance from the Southwest BT (which is level with the corner position) I set a 2½x30" aluminum pipe with aluminum cap marked as shown, 20 inches in the ground with mound of stone 2 ft. base to top of cap from which:

New BTs:


A 11 inch diameter P.Pine bears S320E 76.40 feet marked T3S R41E S29 BT

A 12 inch diameter P.Pine bears S200W 52.14 feet marked T3S R41E S30 BT

A 15 inch diameter P.Pine bears N34°W 15.70 feet marked T3S R41E S19 BT

Set steel fencepost approximately 5 feet North with 54-9 sign attached Corner remonumented June 17, 1986
