Description of corner evidence found:

Nothing was found either during the preliminary reconnaisance or after the corner location was established by double proportionment.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the proportioned location we set a $2\frac{1}{2}$ " brass cap on a $2\frac{1}{2}$ " x 30" galvanized iron pipe 26" in the ground, mkd as shown:

A Tamarack 9" dia. bears N 53° E 19.0' mkd T4N, R40E, S 17 BT A Pine $10\frac{1}{2}$ " dia. bears N 80° W 12.5' mkd T4N, R40E, S 18 BT A Fir 12" dia. bears S $37^{\circ}30$ 'W 6.85' mkd T4N, R40E, S 19 BT A Tamarack $10\frac{1}{2}$ " dia. bears S 47° E 19.95' mkd T4N, R40E S 20 BT

I nailed a brass washer mkd PLS 933 to the BT blazes I set a steel fence post 5° North with signs 54-9 and 54-4 I painted a red band around the BT's and face of scribes I used a steel tape and a magnetic compass with a $19^{\circ}30$ ' East variation and measured a horizontal distance to the center of the BT's with a steel chain
