

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

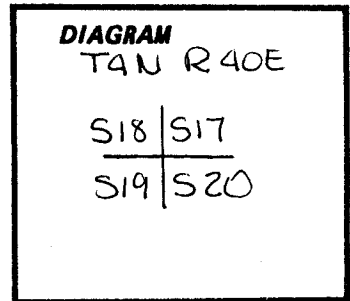

History of original corner establishment:

Corner originally established by Frank Campbell under GLO contract no. 507 in 1884.

Set a Fir post 4 feet long 4ins. square 24" in the ground mkd: T4N S17 on NE R 40E S 20 on SE, S 19 on SW and S 18 on NW faces with 3 notches on S and 5 notches on E edges from which:

- A Fir 18" dia. bears N 28⁰E 40 lks dist. mkd T4N, R40E, S 17 BT
- A Fir 10" dia. bears S 60⁰E 35 lks dist. mkd T4N, R40E, S 20 BT
- A Fir 8" dia, bears S 80⁰W 37 lks dist. mkd T4N, R40E, S 19 BT
- A Fir 8" dia. bears N 50⁰W 36 lks dist. mkd T4N, R40E, S 18 BT



Description of corner evidence found:

Nothing was found either during the preliminary reconnaissance or after the corner location was established by double proportionment.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the proportioned location we set a 2½" brass cap on a 2½" x 30" galvanized iron pipe 26" in the ground, mkd as shown:

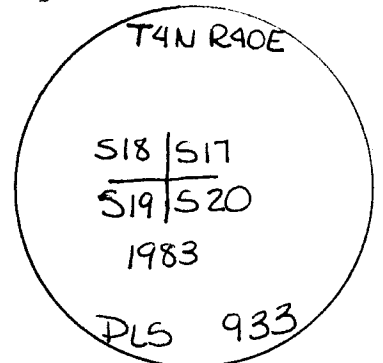
From which:

- A Tamarack 9" dia. bears N 53⁰E 19.0' mkd T4N, R40E, S 17 BT
- A Pine 10½" dia. bears N 80⁰W 12.5' mkd T4N, R40E, S 18 BT
- A Fir 12" dia. bears S 37⁰30'W 6.85' mkd T4N, R40E, S 19 BT
- A Tamarack 10½" dia. bears S 47⁰E 19.95' mkd T4N, R40E S 20 BT

I nailed a brass washer mkd PLS 933 to the BT blazes
I set a steel fence post 5⁰ North with signs 54-9 and 54-4
I painted a red band around the BT's and face of scribes
I used a steel tape and a magnetic compass with a 19⁰30' East variation and measured a horizontal distance to the center of the BT's with a steel chain

This corner was set July 28, 1983
