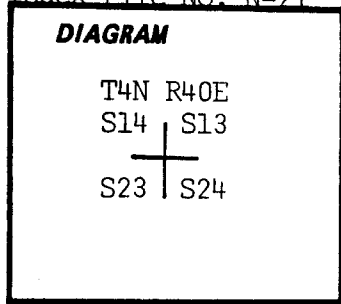


**CERTIFIED RECORD OF LAND CORNER MONUMENTATION**

Index File No. N-21

**History of original corner establishment:**

Corner was originally established under G.L.O. contract No.507 by Frank W. Campbell August 10, 1884. Surveyor General's notes state: "Set a basalt stone 12x12x12 ins. 9 ins. in the ground for cor. to sec's. 13,14,23 and24 marked with 3 notches on S. and 1 notch on E. edges; from which a tamarck 10 ins. diam. bears N83°E., 28 lks dist. marked T4NR40ES13 BT. A fir 10 ins. diam bears S72°E, 12 lks: dist. marked T4N R40E S24 BT. A fir 20 ins. diam. bears S70°W, 19 lks. dist. marked T4N R40E S28 BT. A fir 15 ins. diam. bears N35°W, 16 lks. dist. marked T4N R40E S14 BT."



**Description of corner evidence found:**

Found 12x12x10 inch stone with 3 notches on one side and 1 notch on other side. From which a 32" Fir bears N35°W., 12.7 ft., with grown over blazes. A 32" Fir snag bears S67°W., 13.5 ft. with grown over blazes. A 26" Fir bears S55°E., 8.6 ft., with grown over blazes.

**Description of monument and accessories | established to perpetuate the original location of this corner:**

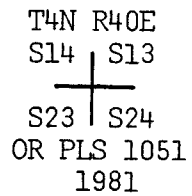
At the above point set 2 1/2" x 30" galvanized pipe and brass cap marked: Set pipe 26" in the ground and buried marked stone alongside.

From which by magnetic declination of N20°E:

A 9" Fir bears N75°E., 55.0 ft. scribed T4NR40ES13 BT.

A 14" Fir bears S79°W., 43.3 ft. scribed T4NR40ES23 BT.

Painted blazes red and 6" red band around. Placed 54-3s, 54-4s and brass washers stamped PLS 1051 on BTs.
