

**CERTIFIED RECORD OF LAND CORNER MONUMENTATION**

V-9

**History of original corner establishment:**

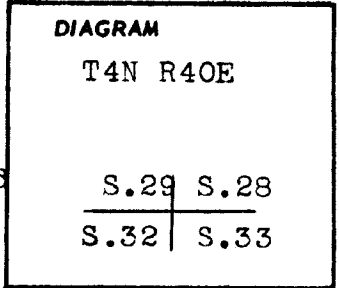
Corner established in 1884 by Frank W. Campbell, under General Land Office Contract No. 507.

Surveyor General Records State:

Set a post (pine) 4" square, 4 ft. long 24" in ground for corner to Sections 28-29-32 & 33 marked:

T4N S.28 in NE; R40E S.33 in SE; S.32 in SW and S.29 in NW faces with 1 notch on S. and 4 notches on E edges from which

- A tamarack, 8" diam bears N.30°E 9 links dist. mkd:T4N R40E S.28 BT
- A spruce 4" diam. bears S.40°E. 4 links dist. mkd:T4N R40E S.33 BT
- A tamarack, 8" diam. bears S.47°W 5 links dist. mkd:T4N R40E S.32 BT
- A spruce, 10" diam. bears N.50°W. 4 links dist. mkd:T4N R40E S.29 BT



**Description of corner evidence found:**

At assumed location I found the rotted end of the original post, from which:

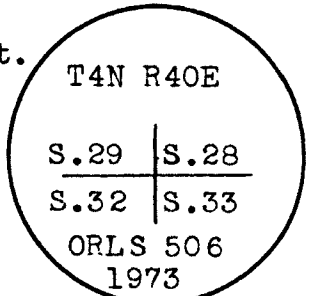
- A tamarack, now 8" snag of ground, scribing visible, bears S.47°W. 5 links (3.3') dist.
- A spruce, found 4' section on ground, tree cut down, bears N.50°W. 4 links (2.64') dist. (portion of scribing visible)

**Description of monument and accessories I established to perpetuate the**

original location of this corner As the evidence found agrees with the original GLO record, I set a 1" galvanized iron pipe with a 2½" Brass Cap (pipe is 36" long) marked

from which: (new BTs)

- A spruce, 11" diam. bears N.66°E. 27,5 feet Dist. marked T4N R40E S.28 BT
- A fir, 8" diam. bears S.14°E. 16.9 feet dist. marked T4N R40E S.33 BT
- A fir, 6" Diam. bears S.43°W. 28.2 feet dist. marked T4N R40E S.32 BT
- A fir, 6" diam. bears N.30°W. 14.5 feet dist. marked T4N R40E S.29 BT



Note: I placed USFS bearing tree signs on the 4 new BTs, and a brass washer stamped ORLS 506 in the lower blaze.
