

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

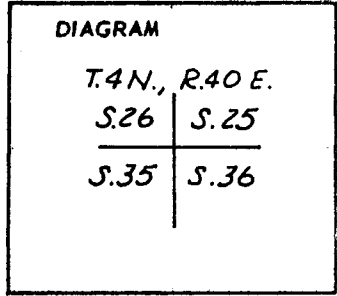

History of original corner establishment:

Corner established by Frank W. Campbell under G.L.O. contract number 507 dated June 28, 1884.

Surveyor General's records state:

Set a basalt stone 18" x 18" x 12" in the ground for the cor to secs 25, 26, 35 & 36 marked with 1 notch on S and E edges from which:



- 1. Fir 24" dia bears N 31° E., 54 lks dist marked T 4 N R 40 E S 25 BT
- 2. Fir 24" dia bears S 30° E., 34 lks dist marked T 4 N R 40 E S 36 BT
- 3. Fir 24" dia bears S 59° W., 36 lks dist marked T 4 N R 40 E S 35 BT
- 4. Tamarack 28" dia bears N 50° W., 9 lks dist marked T 4 N R 40 E S 26 BT

Description of corner evidence found:

Found a basalt stone 18" x 18" x ? 12" above the ground partially underneath a tamarack windfall. No definite chisle work visible.

1. Tamarack snag 26" dia lying on the ground over basalt stone bears N 50° W., 7.9 ft (9 lks) dist with visible scribe marks underneath.

Found decomposed remains of other BT's at G.L.O. record locations.

Description of monument and accessories established to perpetuate the original location of this corner

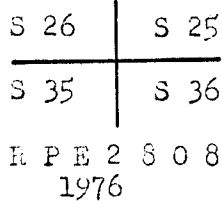
Set a 3" brass tablet with a stem 3" long and 5/8" in diameter in basalt stone at corner point as determined by tamarack BT. Placed a 6' steel fence post alongside corner monument with sign 54-4 attached.

Four bearing trees:

- 1. Larch 11" dia bears N 32° E., 6.6 ft dist marked T 4 N R 40 E S 25 BT
- 2. Larch 10" dia bears N 55° W., 23.8 ft dist marked T 4 N R 40 E S 26 BT
- 3. Fir 10" dia bears S 76° W., 19.8 ft dist marked T 4 N R 40 E S 35 BT
- 4. Fir 7" dia bears S 23° E., 27.0 ft dist marked T 4 N R 40 E S 36 BT

Each BT has a sign 54-3 attached 6" below a band of red paint and has a brass washer marked RPE 2808 nailed flush with BT blaze.

Brass tablet is marked: T 4 N R 40 E
