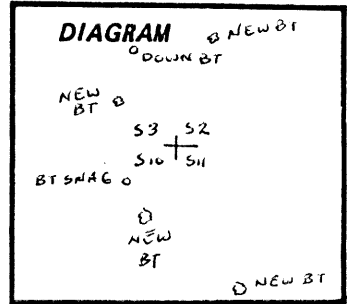


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

**History of original corner establishment:**

Original corner established by Rufus Moore in 1882.  
 Set a basalt stone 18 x 15 x 12 ins, 12 ins in ground for corner marked with 5 notches on the S. and 2 notches on the E edge from which:  
 A 24" Pine bears S86°W, 67 links.  
 A 24" Pine bears N12°W, 237 links.  
 Raised a mound of stone along side the corner stone.

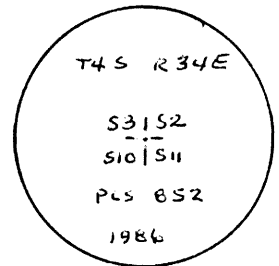


**Description of corner evidence found:**

Stone in mound with faint marks visible, from which:  
 A 20" dead and down Ponderosa Pine bears N24 30'W, 160.7'.  
 A 25" Ponderosa Pine snag bears S83 45'W, 44.2'. The closed scar was opened to verify the scribing.

**Description of monument and accessories established to perpetuate the original location of this corner:**

Moving the stone aside, I set in it's place a 2" x 30" galvanized iron pipe with 2 1/2" brass cap attached. Pipe is set in ground 12" and a mound of stones is built to 1" below the cap. The marked stone is placed alongside the pipe. A steel fence post with USFS Land Survey Monument sign attached is set 5' from the brass cap.  
 The brass cap is amrked:



**New Bearing Trees:**

A 13" Ponderosa Pine bears N64°00'W, 53.2' scribed T4S R34E S3 BT on a double blaze. A 11" Ponderosa Pine bears S37°45'W, 77.3' scribed T4S R34E S10 BT on a double blaze. A 8" Ponderosa Pine bears S21°00'E, 197.0' scribed T4S R34E S11 BT on a single blaze. A 15" Ponderosa Pine bears N9°00'E, 171.0' scribed T4S R34E S2 BT on a single blaze. A 3/4" aluminum washer stamped RLS 852 is nailed between the letters B and T on each tree. Each tree is painted with a 6" red band and has USFS Land Survey Monument and Bearing Tree signs attached.

I hereby certify the above corner point was perpetuated as hereon described on July 14, 1986.
