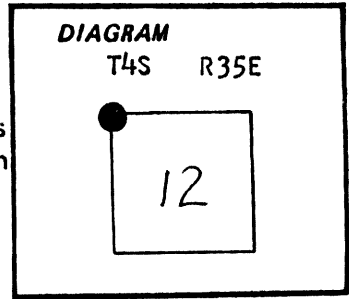


History of original corner establishment: Corner established by Rufus S. Moore under General Land office contract no. 451, dated June 12, 1882. Surveyor General Records states: Set a basalt stone 18"x10"x8", 12 inches in the ground for corner to sections 1, 2, 11, & 12 marked with 5 notches on the South and 1 notch on East edges, from which:



A Pine 34 inches in diameter bears N59°E, 567 lks. dist. marked T4S R35E S1 BT.

A Pine 50 inches in diameter bears N36°W, 150 lks. dist. marked T4S R35E S2 BT.

A Pine 40 inches in diameter bears S13°W, 153 lks. dist. marked T4S R35E S11 BT.

A Pine 55 inches in diameter bears S55°E, 77 lks. dist. marked T4S R35E S12 BT. No record of subsequent remonumentation was found in County Records.

Description of corner evidence found:

- Found stump hole (stumps removed recently) approximately S55°E 51 feet.
- Found a 35" burnt stump S13°W, 101.0 feet, no scribes visible
- Found a 40" stump N36°W, 99.0 feet, BT scribe visible.
- Found a 2"x40" iron pipe filled with concrete approximately 24 feet West of corner position.

Description of monument and accessories I established to perpetuate the original location of this corner: At record bearing and distance from the BTs. I set a 2 1/2"x30" aluminum pipe with aluminum cap marked as shown, 30" in the ground, from which:

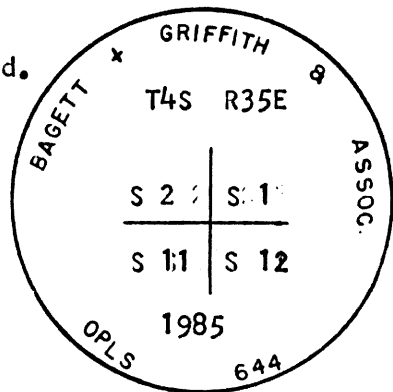
An 11" Ponderosa Pine bears S11°E, 23.36 feet, marked T4S R35E S12 BT

A 17" Ponderosa Pine bears S46°W, 53.11 feet, marked T4S R35E S11 BT

A 12" Ponderosa Pine bears N53W, 57.32 feet, marked T4s R35E S2 BT

No trees available in NE quadrant. Set steel fence post South 4.44 feet with 54-4 sign attached.

Corner set 9/28/85
No witness.



Brass washer nailed to BT blaze. Used steel tape and magnetic compass with 20° East declination. Measured to 50d spike set in right side of tree when facing tree, unless otherwise stated.
