History of original corner establishment:

Corner was established by Rufus S. Moore, US

Deputy Surveyor, during the original survey

Contract No. 451 dated June, 1882.

Set a post 3 ft. long, 3 ins. sq., 24 ins. in

ground, for % sec. cor., marked %S on W. face; from

which

A tamarack 20 ins. diam., bears N32*W, 37 lks. dist., marked 1/4 S BT

A tamarack 30 ins. diam., bears N12*E, 44 lks. dist., marked 1/4 S BT

Corner was temporarily set at proportionate distance between the section corners by Richard Shaver and Thomas Milne in 1988. They knew this Forest Service contract was to be performed.

No evidence of the orginal corner was found.

 Λ No. 5 rebar with a yellow plastic cap was set to marked their computed corner location as shown on Map of Survey 41-88.

Description of corner evidence found:

No evidence of the corner was found. Inquiry was made to try to find records for the Mt. Emily logging railroad as a search tool, but no success. Milne and Shaver had made an extensive search for corner evidence with no positive results. The corner is at the toe of State Highway 244 fill. There is one old larch stump that might be the old BT, but no scribing or blaze could be found. I visited with several people who have looked for this corner with no success.

20" tamarack (1882 BT) not found. 30" tamarack (1882 BT) not found.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a 2"x30" aluminum pipe with a 24" aluminum cap, marked as shown in the diagram, 28" in the ground, at single proportionate measurements from adjacent found corners in place of the No. 5 rebar. A mound would not stay in place on the highway fill., from which new BTs are:

12° Ponderosa pine bears N48°M, 20.3 feet scribed 1/4 S8 BT

Attached BT and Land Survey Monument signs to and painted a red band around each BT. Bearings were turned from the control traverse with a theodolite, basis of bearing being the bearing between the SE and S% corners of Section 7 as shown on MOS 43-76, to stamped brass washers nailed in the scribed red-painted blazes. Distances were measured from a 60d spike, with an aluminum washer stamped PLS 699, which was driven into the side of each BT approximately one foot above the ground. Set a steel fence post 5 feet N of the corner with a Land Survey Monument sign attached. The monument is not a National Forest property corner
