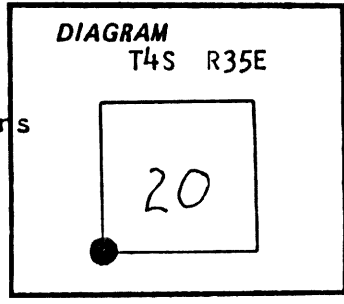


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: Corner established by Rufus S. Moore under General Land office contract no. 451, dated June 12, 1882. Surveyor General Records states: Set a basalt stone 30"x15"x7", 24 inches in the ground for corner to sections 19, 20, 29, & 30 marked with 2 notches on the S and 5 notches on E edges and raised a mound of stone alongside, from which:



A Pine 36" in diameter bears $N63^{\circ}W$, 65 lks. dist. marked R35E S19 BT

A Pine 30" in diameter bears $S46^{\circ}W$, 102 lks. dist. marked T4S R35E S 30 BT

No record of subsequent remonumentation was found in County Records.

Description of corner evidence found:

Found Stone 28"x15"x7", marked with 2 grooves on face and 1 good mark on edge in mound of stone.

Found a Pine stump 30" \pm $S46^{\circ}$ 67.3 feet, no scribes visible, a chip nearby has ax marks.

Found a Pine stump burned 30" \pm $N65^{\circ}W$, 42.9 feet, no scribes visible

Description of monument and accessories I established to perpetuate the original location of this corner: In place of stone, I set a 2 1/2"x30" aluminum pipe with aluminum cap marked as shown, 15" in the ground with surrounding mound of stone 5 feet base to cap, from which:

A 5" Ponderosa Pine bears $N60^{\circ}E$, 19.48 feet, marked X BT

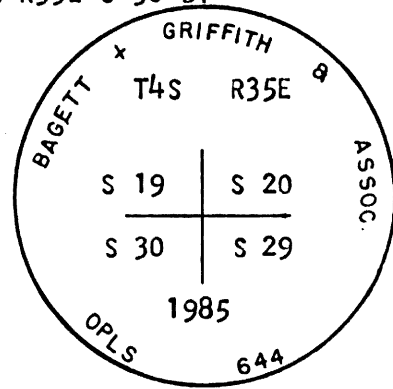
A 12" Ponderosa Pine bears $S7^{\circ}E$, 69.82 feet, marked T4S R35E S29 BT

An 8" Ponderosa Pine bears $S54^{\circ}W$, 126.52 feet, marked T4S R35E S 30 BT

A 14" Ponderosa Pine bears $N32^{\circ}W$, 55.30 feet, marked T4S R35E S19 BT

Buried stone North
Set a Steel fence post approximately 5 feet North with a 54-4 sign attached.
