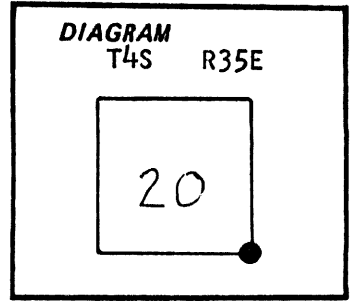


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: Corner established by Rufus S. Moore under General Land office contract no. 451, dated June 12, 1882. Surveyor General Records states: Set a Basalt stone 16"x9"x7", 11 inches in the ground for corner to sections 20, 21, 28, & 29 marked with 2 notches on S and 4 notches on E edges, from which:



A Tamarack 15 inches in diameter bears S72°E 48 lks. dist. marked S28 BT

A Fir 13 inches in diameter bears S42°W, 29 lks. dist. marked S 29 BT.

A Fir 18 inches in diameter bears N22°E, 38 lks. dist. marked T4S S21 BT

A Fir 16 inches in diameter bears N52°W, 10 lks. dist. marked R35E S20 BT
No record of subsequent remonumentation was found in County Records.

Description of corner evidence found:

Found stone firmly set 14"x10"x8" marked with 2 and 4 grooves.

Found SE BT, a 24" stump with blaze evident badly rotted, found scribing.

Found SW BT, An 18" fir dead and down, rotted, no scribes visible.

Description of monument and accessories I established to perpetuate the original location of this corner: In place of stone, I set a 2 1/2"x30" aluminum pipe with aluminum cap marked as shown, 28 inches in the ground, from which:

A 10" Douglas Fir bears N67°E, 25.51 feet marked T4S R35E S21 BT

An 8" Tamarack bears S44°E, 24.96 feet marked T4S R35 E S28 BT.

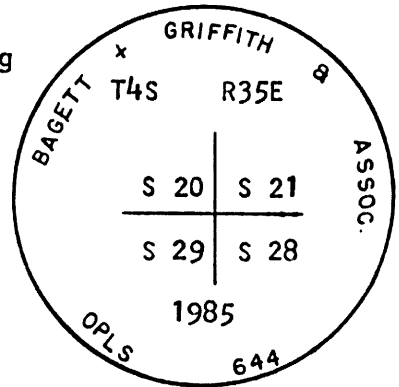
A 6" Ponderosa Pine bears S13°W, 21.97 feet marked X BT

A 14" Douglas Fir bears N24°W, 12.24 feet, marked T4S R35E S20 BT. Spike set on left side of tree when facing tree. This bearing tree is a double bole.

Buried Stone North.

Set steel fence post approximately 5 feet North with 54-4 and 54-2 sign attached.

Set steel fence post approximately 5 feet East with 54-2 sign attached.



Corner set 10/8/85

Witness: Greg Blackman, Rick Robinson

Brass washer nailed to BT blaze. Used steel tape and magnetic compass with 20° East declination. Measured to 50d spike set in right side of tree when facing tree, unless otherwise stated.
