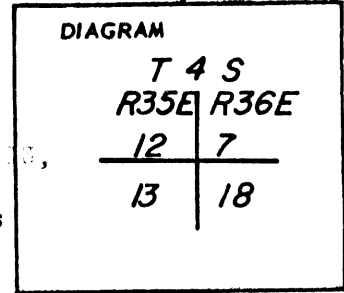


**CERTIFIED RECORD OF LAND CORNER MONUMENTATION**

**History of original corner establishment:** Corner established in 1881 by Jacob C. Cooper under General Land Office contract No. 397. Surveyor General Records State:

Set post 4½ feet long 4" square, 2 feet in the ground in open pine timber, slope N.E., for corner to sections 7, 12, 13, & 18, marked T4S.S7, on the NE., R.36E., S 18 on SE., R. 35 E. S 13, on SW., and S 12 on N.W. faces with 4 notches on South and 2 notches on N. edges, from which;



A pine 18" diameter, bears S 11 W, 96 lks. dist. marked T 4 S., R. 35 E. S 13 B.T.

A pine 16" diameter, bears S 23 E 126 lks. dist., marked T. 4 S., R. 36 E. S 18 B.T.

A pine 40 " diameter, bears N 26 W 98 lks. dist., marked T. 4 S., R. 35 E. S 12 B.T.

No record of subsequent remonumentation was found in county records.

**Description of corner evidence found:**

Found SE. B.T.

A pine stump with scribes visible.

Found NW. B.T.

A 40" pine stump, the bottom of the blaze face visible, no scribes visible.

No other B.T. found.

**Description of monument and accessories established to perpetuate the original location of this corner**

At record bearing and distance from each B.T., I set a 2½x30" Iron pipe with brass cap marked as shown, 25" in the ground, and raised a mound of stone from which:

New B.Ts.:

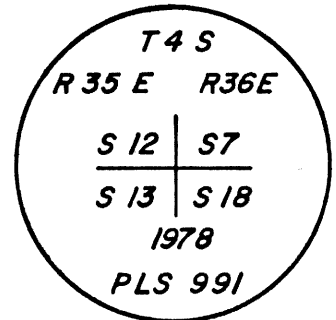
A pine 15" in diameter bears N 67 E, 58.1 ft., marked T 4 S. R. 36 E. S. 7 BT.

A pine 16" in diameter bears S 69 E, 71.50 ft., marked T 4 S. R. 36 E. S 18 BT.

A pine 14" in diameter bears S 46 W, 26.2 ft., marked T 4 S. R. 35 E. S 13 BT.

A pine 11" in diameter bears N 81 W, 66.5 ft., marked T 4S. R. 35 E. S. 12 BT.

I used a steel tape and a magnetic compass with 20 deg. East declination set into the compass.
