In Survey Number 042-1993, Linda Lee Miller monuments the corner. Union County Survey 042-1993 states:

No evidence of original corner remains. Set monument as shown hereon at position determined by survey, from which: Marked bearing trees:

Found a 2 1/2" iron pipe with 2 1/4" brass cap in a 1 ft. mound of stone, set by Survey 042-1993. This was proven incorrect by Survey Number 037-1995 and therefore rejected. No remaining evidence of original GLO corner could be found.

At proportionate position, I set a 2 1/2" x 30" aluminum pipe, 26" in the ground, with a 3" aluminum cap marked as shown, in a 1.5 ft. diam, mound of stone, from which:
