
HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner noted by W.B. Blakeley in Old Book Survey number 186, page 315. Union County Survey record states: Corner to 17-16-20-21, rock in mound of rock 12 \times 12 \times 20

Corner found in 1938 by Union County Highway Department and tied in Union County Road record 20121. Record shows coordinate by local control.



DESCRIPTION OF CORNER EVIDENCE FOUND:

None. Multiple rock piles exist along ancient fence lines in the area.

At position by survey I set a 2 1/2" x 30" aluminum pipe, 26" in the ground, with a 2 $\frac{1}{2}$ " aluminum cap marked as shown below, with 3' diam. mound of stone base to top of cap, from which:

A 5/8" x 15" iron pin bears North 46°42' East a dist. of 15.65 ft., with 1 $\frac{1}{2}$ " aluminum cap marked NE RP.

A 5/8" x 15" iron pin bears South 32°07' East a dist. of 17.73 ft., with 1 $\frac{1}{2}$ " aluminum cap marked SE RP.

A 5/8" \times 30" iron pin bears South 31°04' West a dist. of 18.03 ft., with 1 $\frac{1}{2}$ " aluminum cap marked SW RP.

A 5/8" x 15" iron pin bears North 47°01' West a dist. of 14.21 ft., with 1 $\frac{1}{2}$ " aluminum cap marked NW RP.

Set steel fence post approx. 2' East.




