DESCRIPTION OF CORNER EVIDENCE FOUND:

Found a 2 $\frac{1}{2}$ " iron pipe with a 2 $\frac{1}{2}$ " brass cap, marked as shown below, lying horizontal 6" below ground surface. From which:

A 15" Larch stump bears South 4° East, a distance of 26.40 feet, no scribing visible. A 24" Douglas Fir stump bears North 71° West, a distance of 52.75 feet, with BT scribing visible.

Due to recent logging activity, this monument has been disturbed. I reset this monument at the base of the found position. I find this to be relatively harmonious with the found stump accessories, being record distance from the South bearing tree stump, and record bearing from the Northwest bearing tree stump.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

I reset the old iron pipe monument, 20" in the ground with a mound of stone 2 foot base to top of cap. From which:

A 5/8" iron pin bears North 29° East, a distance of 13.40 feet, with a 1 ½" aluminum cap marked BGB SURVEY MARKER NE RP.

iron pin bears South 63° East, a distance of 7.85 feet, with a 1 ½" aluminum cap A 5/8" marked BGB SURVEY MARKER SE RP.

A 5/8" iron pin bears South 57° West, a distance of 10.65 feet, with a 1 $lag{1}{2}$ " aluminum cap marked BGB SURVEY MARKER SW RP.

A 5/8" iron pin bears North 56° West, a distance of 12.00 feet, with a 1 ½" aluminum cap marked BGB SURVEY MARKER NW RP.




