History of original corner establishment:

Corner originally established by Rufus S. Moore, U.S. Deputy Surveyor, under GLO contract No. 451 dated June 12, 1882. Surveyor General records state:

Set a basalt stone 14x10x5 - 10 ins in ground for 1/4 sec cor marked 1/4 S on N face. From which:

A pine, 32 ins. in dia. bears N40°E, 52 lks. dist., marked 1/4 S B T. A pine, 50 ins. in dia. bears S32°W, 79 lks. dist., marked 1/4 S B T.

In 1984 David E. Scott, PLS 1844, found a stone 14x10x6 marked 1/4. From which:

A 32" P. Pine snag 20 ft. tall bears N40°E, 34.3 ft., blaze pitched over. A 54" stump 32" high scribed BT, bears S32°W, 52 ft., measured to blaze.

At location of stone, Scott set a 2 1/2" aluminum cap on a 2 3/8"x30" aluminum pipe, 7" above ground, stamped as shown in Corner Diagram, from which:

A 6" P. Pine bears S49°W, 39.8 ft., blazed and scribed 1/4 S36 BT.

A 5 1/2" P. Pine bears N31 1/2°E, 37.2 ft., blazed and scribed 1/4 S25 BT.

Description of corner evidence found:

Found 2 1/2" diameter aluminum cap on 2 3/8"x30" aluminum pipe, 7" above ground. Steel fence post 3.7' West of corner monument with 54-2 and 54-4 signs. Area burned by Fly Fire in 2005. All 1882 and 1984 bearing trees are now stumpholes.

Description of monument and accessories I established to perpetuate the original location of this corner:

Build stone mound around corner monument. Most trees in area are dead.

New accessories:

A 2" aluminum cap on 5/8"x30" rebar bears N26°E, 20.7' in stone mound.

A Ponderosa Pine 15" in diameter bears S4°E, 47.9' scribed 1/4 S36 BT.

A Ponderosa Pine 10" in diameter bears S54'W, 40.8' scribed X BT.

A 2" aluminum cap on 5/8"x30" rebar bears N25°W, 17.3' in stone mound.

Aluminum caps are marked as shown on Typical Cap below.

New bearing trees have 54-3 and 54-9 signs attached, a brass washer stamped PLS 2672 nailed between the B and T on the lower face, and a 6" red painted band. Bearing tree faces are also painted red. The distance is measured to a 60d spike in the right side center of the bearing trees.
