

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner originally established in 1984 by David E. Scott, PLS 1844, under U.S. Forest Service contract. Scott's notes state:

Set 2.5" aluminum cap on $2\ 3/8$ " x 30" aluminum pipe rising 6" above ground. Set steel fencepost 3.0 ft. east of corner.

New BT's:

8" Tamarack bears S36.5°W, 53.8 ft., blazed and scribed: N 1/16 S35 BT. 10" Tamarack bears S55°E, 56.3 ft., blazed and scribed: N 1/16 S36 BT.

Description of corner evidence found:

Found two bearing trees set by Scott in 1984. No trace of corner monument and fencepost. Corner may have been destroyed by fence building activities.

Remaining Accessories:

A Tamarack, 13" in diameter bears S36.5°W, 53.8' with visible scribing. A Tamarack, 14" in diameter bears S55'E, 56.3' with no visible scribing.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a 3 1/4" aluminum cap on a 2 1/2" x 30" aluminum pipe flush with ground in a small rock collar at record bearing and distance from Scott's bearing trees. Marked as shown in the Corner Diagram.

Set a galvanized steel post 5' east with 54-2 and 54-9 signs.

Bearing trees have 54-3 and 54-9 signs and have a 6" red painted band. The bearing tree face or blaze is also painted red.

Corner monument is 6' south of an east—west fenceline.

W 118°30'23.25"

Geodetic coordinates were obtained from a Trimble Geo-Explorer mapping grade GPS receiver and have been differentially corrected.
