
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

In 1882, under GLO Contract No. 397, J. Cooper set post $3\frac{1}{2}$ Ft. long 3 ins. square 18 ins. in ground on Island for 1/4 Sec. corner marked 1/4S on E. and W. faces.

A Pine 18 ins. dia. bears $\mathrm{S30}^{\,\mathrm{O}}$ East 115 lks. dist. marked 1/4 S BT.



Description of corner evidence found:

At corner location found rotted remains of BT with faint "1/4S" visible. Found rotted remains of tree scattered in about a 6 Ft. square area. Used center of area for BT location. At record bearing and dist. $(N30^{\circ}W, 75.9 \text{ Ft.})$ established 1/4 corner position. This position falls at record call dist. North of ledge of rock, course E and W (2.50 chains). This position also matches the call of 2 chains to Grand Ronde River very well. Could find no evidence of the original post.

Description of monument and accessories I established to perpetuate the original location of this corner:

At established point set $2\frac{1}{2}$ "x30" galvanized pipe with brass cap stamped: Set pipe 24" in ground with 4 Ft. dia. mound of stones and dirt to cap.

A Lodgepole Pine 9" dia. bears N7 $^{\rm O}$ E. 236.5 Ft. scribed 1/4 S19 BT. A Rock 33"x41" - 24" high bears S10 $^{\rm O}$ W, 131.0 Ft. marked B.O. X

Attached signs and painted trees per $\underline{\text{Standard Specifications}}$ $\underline{\text{For Cadastral Surveys}}$, U.S.F.S. Region 6, Oct. 1979.

Attached 54-4 sign to metal post 6 Ft. North of corner. Attached 54-3 & 54-4 signs to metal post next to B.O. rock.

Corner falls on small rise in marshy meadow 130 Ft. South of river and 230 Ft. South of paved road. BT falls on South side of paved road.

Compass Declination: 190 East
