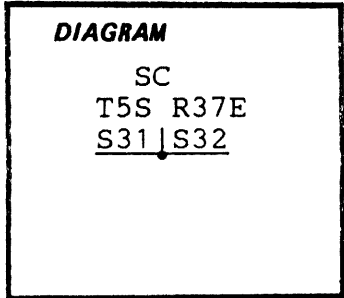


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:



Original corner established in 1881 by Jacob C. Cooper under contract #397. Set a post 4"x4"x4½', 2 ft. in ground. From which:

- A 4" Pine bears N85°E, 26 lks.
 - An 8" Fir bears N82°W, 39 lks.
- William R. Gradon under contract No. 445 when sub-dividing T5S, R37E added a 7" Pine bearing S70°W, 39 Lks.

Description of corner evidence found:

Found no trace of original post.
 Found the following original bearing trees:
 An 11" dead standing lodgepole pine bears N85°E, 26 lks., partially healed blaze, 7ES3 visible.
 A dead, down & decayed fir with slab with axe marks visible bears N82°W, 39 lks.
 A decayed lodgepole pine stump bears bears S70°W, 39 lks.
 No marks visible.

Description of monument and accessories I established to perpetuate the original location of this corner:

Cap is stamped: SC
 At the position established from the orig. BT's, I set a 2½"x30" aluminum capped aluminum pipe rising 14" in a mound of stones. T5S R37E
 I set a steel fencepost 3' North of corner S31 | S32
 New BT's: RLS 1848
 1987
 A 4½" Alpine Fir bears N28¾°E, 5.6 ft., blazed&scribed: T5SR37ES32SCBT
 A 6" Alpine Fir bears N73½°W, 5.3 ft., blazed&scribed: T5SR37ES32SCBT

Painted blazes and attached signs as per Standard specifications for Cadastral Surveys, USFS Region 6, March 1982. A ¾" brass disk stamped "RLS 1848" was nailed to the lower end of the blazes.

Follow road out to Rocky Point off 5125 for 0.7 Mi. New road forks off to NW around West side of ridge top. Corner is on South edge of flat top knoll in edge of lodgepole and fir thicket.
