This $\frac{1}{4}$ corner was set by deputy surveyor W.B. Barr, under Contract No. 388 dated May 7, 1881. He states he set a basalt rock 12" x 9" x 6" in a mound of rock.

Description of corner evidence found:

At the assumed $\frac{1}{4}$ corner location I found a basalt stone 15"x 10"x 6" being set in a small mound of stone of which was partially covered by grass & sod. Stone has no visible markings, however it fit very closely to several GLO calls along the line between Sections 24 & 25.

Description of monument and accessories I established to perpetuate the original location of this corner:

With the evidence closely agreeing to the description of the GLO notes and the ‡ corner position appears correct by survey, I accepted the center of the hole left by the stone, to be the true ‡ corner. I then set an Alum. cap on a 2" x 30" pipe with a magnet fixed in the cap, at the corner location. I buried the pipe to within 6" above the surface of the ground, and the stone I found I buried along the west side of the pipe. I then placed a mound of stone 3 feet dia. and 1 foot high covering the monument. From which I set two new bearing trees:

A pine 8" dia. bears N 80 00 E, 22.44 feet and scribed $\frac{1}{4}$ S S 24 BT. A pine 5" dia. bears S 34 30 W, 35.15 feet and scribed $\frac{1}{4}$ S S 25 BT.

HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

Originally established by W.B. Barr under GLO Contract No. 388, dated May 7, 1881. Surveyor record states:

Set basalt stone 12x9x6 in a mound of rock

James Hambleton, in Union County Survey No. 28-87, finds a basalt stone 15"x10"x6" in a small mound of stone. No markings found, but position fits topo calls of original GLO field notes. Monumentation record 110-87R states:

I accepted the center of the hole left by the stone, to be the true 1/4 corner. I then set an Alum. cap on a 2" x 30" pipe with a magnet fixed in the cap, at the corner location. Found 2 1/2" aluminum pipe with aluminum cap marked as shown below, in a mound of stone 30" diam, 2" above ground, from which:

A 17 inch Ponderosa Pine bears North 80° East, a distance of 22.28 feet, alive and vigorous with a healed blaze.

An 8 inch Ponderosa Pine bears South 35° West, a distance of 35.27 feet, alive and vigorous with a healed blaze.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

From aluminum monument position,

NEW BEARING OBJECTS:
