

Description of monument and accessories I established to perpetuate original location of this corner:

At the position determined by survey, I set a standard USFS 2% ins. diam. by 30 ins. long alum. pipe, 28 ins. in ground, with 3% ins. diam. alum. cap, and rock collar, with clear DEEP-1 magnet at base, mkd as shown:

From which:

A white fir, 12 ins. diam., bears N. $5\frac{1}{2}$ ° E., 33.6 ft. dist., mkd. C1/4 BT. A lodgepole pine, 10 ins. diam., bears S. $29\frac{1}{2}$ ° E., 35.6 ft. dist., mkd. C1/4 BT. A lodgepole pine, 13 ins. diam., bears S. 69° W., 51.7 ft. dist., mkd. C1/4 BT. A tamarack, 20 ins. diam., bears N. $66\frac{1}{2}$ ° W., 75.5 ft. dist., mkd. C1/4 BT.

All new bearing trees are marked on a single blaze and have a nail with a brass washer stamped "LS 2648" right side center for distance measurements.

Set guard posts ± 5 ft. S'ly with Land Survey Monument (54-9) and Property Boundary (54-2) signs and ± 5 ft. W'ly with Property Boundary (54-2) sign.

Painted 6 ins. red bands and added Bearing Tree (54-3) and Land Survey Monument (54-9) signs to all bearing trees.

Auto C/A geographic position: Lat. 45°05'09.1" N Long. 118°06'19.9" W
