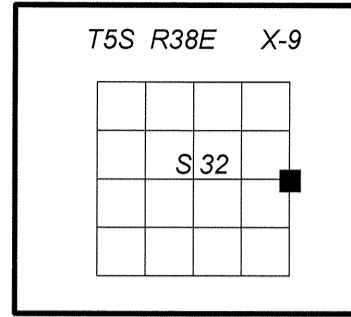


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Original corner set by William B. Barr, under GLO Contract No. 388, approved December 31, 1881.
 Record States: Set Stake 4 ft long 4 in diam 18 in ground for ¼ sec corner, from which:
 Fir, 5 in diam., bears N 70° W, 10 lks dist.
 Tamarack, 5 in diam., bears S 62° E, 12 lks dist.



Description of corner evidence found:

Thorough search of area finds no evidence of original corner. Search area has been logged extensively. Corner is determined lost and reestablished by proportionate measurement.

Description of monument and accessories I established to perpetuate original location of this corner:

At the position determined by survey, I set a standard USFS 2½ ins. diam. by 30 ins. long alum. pipe, 28 ins. in ground, with ¾ ins. diam. alum. cap, and rock collar, with clear DEEP-1 magnet at base, mkd as shown:

From which:

- A Douglas fir, 6 ins. diam., bears N. 63¾° E., 19.8 ft. dist., mkd. X BT on double blaze.
- A Douglas fir, 11 ins. diam., bears S. 46° E., 58.8 ft. dist., mkd. 1/4 S33 BT.
- A ponderosa pine, 10 ins. diam., bears S. 37½° W., 33.2 ft. dist., mkd. 1/4 S32 BT.
- A tamarack, 5 ins. diam., bears N. 6° W., 63.3ft. dist., mkd. XBT.

Set guard post ±1 ft. NE'ly with Land Survey Monument (54-9) sign attached.

All new bearing trees are marked on a single blaze unless noted otherwise and have a nail with a brass washer stamped "LS 2648" right side center for distance measurements.

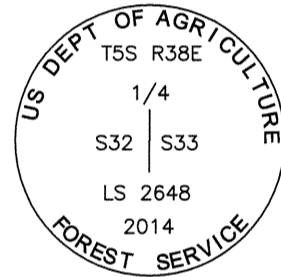
Painted 6 ins. red bands and added Bearing Tree (54-3) and Land Survey Monument (54-9) signs as needed to all bearing trees.
