

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

T. Davenport surveyed the First Standard Parallel South under contract No. 102 dated July 20, 1863.

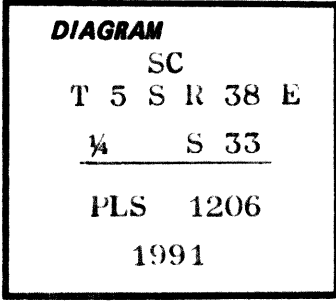
Record states:

Set post, from which  
A Pine 12 inch in dia. bears N 50° E 43 lks.  
A Red fir 18 inch " " S 35° E 33 " dist.

W. Barr retraced the First Standard Parallel South under contract No. 588 dated May 7, 1881.

Record states:

Corner destroyed, trees standing and agreeing with description  
Pine 12 in diam. bears N 30° E 43 lks. dist.  
Fir 18 " " " S 35° E 33 " "  
Reestablished by planting Basalt rock 14 x 10 x 5



Description of corner evidence found:

Found rotted Ponderosa Pine remains, size indeterminate, bears N. 30 E. 28.4 feet dist. marked "BT". No remains of stone or other bearing tree found. Area has been logged several years ago.

Description of monument and accessories established to perpetuate the original location of this corner:

At the corner point as reestablished from the found bearing tree remains, set 1½" x 30" galv. iron pipe 24" into the ground, constructed 36" dia. stone mound around the monument. 2½" brass cap is marked as shown in the corner diagram.

From which, new bearing trees:

- A 10" dia. white fir bears N. 7° W., 8.0 feet dist. marked ¼ S33 SC BT on a double blaze.
- A 10" dia. white fir bears N. 30° E., 11.3 feet dist. marked ¼ S33 SC BT on a double blaze.
- A 12" dia. white fir bears S. 8° W., 2.8 feet dist. marked ¼ S33 SC BT on a double blaze.
- A 15" dia. Douglas fir bears S. 50° W., 21.8 feet dist. marked ¼ S33 SC BT on a double blaze.

Set steel fence post 2' east of monument. Attached U.S.F.S. 54-3 signs to bearing trees.

I certify that the above corner was properly monumented under my direct supervision on November 6, 1991, as witnessed by Larry McBroom and Mike Parker.
