corner destroyed by fire, one tree standing and agreeing with description Pine 30 in diam bears S. 35° W. 240 lks. dist. Reestablished by planting Basalt rock 17 x 12 x 5.

Description of corner evidence found:

Found stone 20" x 10" x 5" set in 36" dia. stone mound, no visible markings.

From which: An 18" dia., 42" high burnt Ponderosa Pine stump bears S. 35° W., 158.4 feet dist., part of burnt blaze, with some scribing visible but not legible was found lying on the ground beside the stump.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the point previously occupied by the found stone, set 1%" x 30" galv. iron pipe 24" into the ground, constructed 36" dia, stone mound around the monument. 2½" brass cap is marked as shown in the corner diagram.

From which, new bearing trees:

A 9" dia. Ponderosa Pine bears S. 77° E., 34.5 feet dist. marked 54 SC BT on a double blaze.

Buried original stone 1' north of the monument. Set fence post 2' east of the monument. Attached U.S.F.S. 54-3 signs to the new bearing trees.
