
CENTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

The exterior township lines of T5S, R39E, W.M. were originally surveyed by Timothy W. Davenport under General Land Office Contract No. 102, approved January 12, 1864. The field notes for this survey state:

"Set post corner to sections 5, 6, 31 & 32 made mound of rock"



DESCRIPTION OF CORNER EVIDENCE FOUND:

Found mound of stone 4 ft. in diameter with old wood post laying next to mound, hollow spot in mound with remnants of wood at center.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At center of found mound of stone: Set a $3\frac{1}{4}$ in. diameter aluminum cap on a $\frac{5}{8}$ in. diameter by 30 in. long iron rod (rebar), driven 26 inches into the ground, with clear Berntsen DEEP-1 magnet placed alongside in mound; rebuilt mound of stone to top, a t-post place alongside 1.2 ft. E'ly, marked as shown:


From which lestablish the following reference monuments:

A $\frac{5}{8}$ in diameter by 30 in long iron rod (rebar) with a $1\frac{1}{2}$ in diameter aluminum cap, driven 26 in into the ground, mkd.: "ODOT NE" bears N39°E, 9.99 ft.

A $\frac{5}{8}$ in diameter by 30 in long iron rod (rebar) with a $1\frac{1}{2}$ in diameter aluminum cap, driven 28 in into the ground, mkd.: "ODOT SE" bears S34°E, 10.17 ft.

A blue Berntsen DEEP-1 magnet, buired 6 in. into the ground, bears S57° W, 8.42 ft.

An orange Berntsen DEEP-1 magnet, buried 8 in. into the ground, bears N40° W, 10.07 ft.



Accessories taken with steel tape and hand compass set at 19° East declination.
