This section corner was set by deputy surveyor Timothy W. Davenport, under contract No. 102, dated July 20, 1863. He states he set a post for corner to Sec's 7, 18, 12 & 13; made mound of rock.

Description of corner evidence found:

At the assumed section corner location I found no trace of the original corner, as the ground is very steep and there has been heavy stock over the area around the corner location.

Description of monument and accessories I established to perpetuate the original location of this corner:

With no evidence of the original corner available, I then established this section corner, using single proportioning. I then set an Alum. cap on a 2" x 30" pipe, with a magnet fixed in the cap, at the corner location. I buried the pipe to within 6" above the surface of the ground. I then placed a mound of stone $3\frac{1}{2}$ feet dia. and $1\frac{1}{2}$ feet high anchored into the hillside and covering the monument; from which I set one bearing tree.

A pine 22" dia. bears N 37 45 W, 71.67 feet and being scribed T 5 S R 38 E S 12 BT.

No other bearing trees available in the vicinity of this corner.



A 5/8" X 30" rebar with 1 ½" aluminum cap bears South 27 West, a distance of 11.63 feet, marked "UNION COUNTY SURVEYOR SW RP".

Corner falls on a steep East facing slope, 8 ft. South of an East/West running barbed wire fenceline. Fence is downed and in a state of disrepair.


