
## CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Description of monument and accessories I established to perpetuate the original location of this corner: In place of stone, I set a  $2^{\frac{1}{2}}x30^{\frac{11}{2}}$  aluminum pipe with aluminum cap marked as shown, 28 inches in the ground with mound of stone 2 ft. base to top of cap from which:


