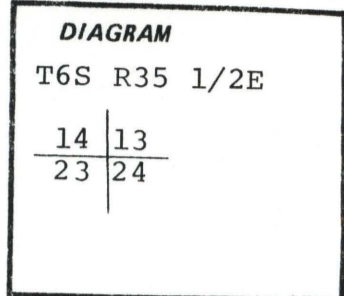


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. N-21

History of original corner establishment: Original corner established in 1883 by William B. Barr under Contract No. 492.



A 15"x12"x6" stone was set, from which:
a 10" Pine bears N40°E, 44 lks.,
a 10" Tamarack bears S20°E, 37 lks.,
a 6" Pine bears S45°W, 32 lks., and
a 48" Tamarack bears N70°W, 32 lks.

Description of corner evidence found:

Found original stone with notches N10°E, 10.5 ft. At the position established from the original S14 & S24 BTs, I found an indentation 6" deep filled with organic material.

Bearing trees found:

6" W. Larch, dead & down, bears S20°E, 37 lks, blaze and scribing visible: T6S R35 1/2E S24 BT.
33" W. Larch, live, good condition, blaze healed over.

Description of monument and accessories established to perpetuate the original location of this corner:

Cap is stamped:

Set 2.5"x30" aluminum capped aluminum pipe rising 5" out of the ground with the original stone buried alongside. Set steel fence post 3 ft. north of corner.

New BT's:

7.5" W. Larch bears N51°E, 118.3 ft., blazed & scribed: T6S R35 1/2E S13 BT.
7" D. Fir bears S70°E, 36.9 ft., blazed & scribed: T6S R35 1/2E S24 BT.
6.5" W. Larch bears S11 1/2°W, 88.5 ft., blazed & scribed: T6S R35 1/2E S23 BT.

Painted blazes and attached signs as required in Specifications for Cadastral Surveys, USFS Region 6, March 1982. Attached 3/4" brass washer marked RLS 1848 to blazes.

To find corner, from USFS Rd. 5178028, follow 5178025 southerly 1/4 mi. east up the hill to small knob. Corner is SE 300 ft. in saddle.

Compass Declination: 19 1/2°E
