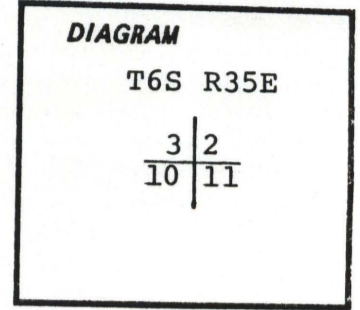


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. E-17

History of original corner establishment:

The original subdivision of T6S, R35E, was by Herman D. Gradon under Contract No. 499, approved November 24, 1884. At this corner he set a stone 18x8x6, from which an 11" Pine bears N21°E, 79 lks. and a 16" Pine bears S60°W, 7 lks., a 10" Pine bears S49°E, (distance is unreadable), and an 8" Pine bears N54°W, 83 lks.



Description of corner evidence found:

Found stone 13x8x6, firmly set.

Bearing trees found:

- A 24" P. Pine stump 18" high, bears S50°E, 84.0 ft., scribed: (BT)
- A 16" P. Pine stump bears N54°W, 54.8 ft.
- A 22" P. Pine, dead and down, bears N21°E, 52.1 ft.

Description of monument and accessories established to perpetuate the original location of this corner:

Set 2.5" aluminum cap on 2 3/8"x30" aluminum pipe rising 14" above ground in mound of stone. Buried original stone on north side of cap. Set Steel fence post 4.0 ft. north of corner.

- 5" P. Pine bears N28 3/4°W, 50.0 ft., B&S T6S R35E S3 BT.
- 14" P. Pine bears S65.5°W, 34.8 ft., B&S T6S R35E S10 BT.
- 11" P. Pine bears S34.5°E, 29.3 ft., B&S T6S R35E S11 BT.
- 8" Juniper bears N73 1/4°E, 82.7 ft., B&S T6S R35E S2 BT.

Brass LS 1844 disc in lower end of blazes. Painted blazes and attached signs as per Standard Specifications for Cadastral Surveys, USFS Region 6, March 1982.

Compass Declination: 19 3/4°E.

Corner is found 300 ft. north of Rd. 5160 on south slope, 800 ft. east of Rd. 5160-157.
