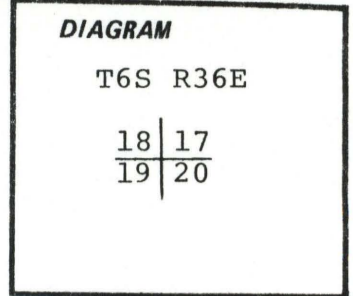


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. N-05

History of original corner establishment: Original corner established in 1883 by William B. Barr under Contract No. 492.



An 18"x10"x6" stone was set, from which:  
 An 18" Fir bears N80°E, 45 lks.,  
 A 48" Pine bears S50°E, 56 lks.,  
 A 36" Fir bears S45°W, 32 lks., and  
 a 24" Fir bears N30°W, 60 lks.

Description of corner evidence found:

No corner monument found.

Bearing trees found:

30" Fir stump bears N78°E, 31.3 ft., no marks.  
 72" Pine, dead & down, bears S50°E, 17.2 ft., open blaze, scribing visible: T6S R36E S20 BT.  
 32" Fir stump bears N33 1/2°W, 39.2 ft., portion of blaze with scribing visible.

Description of monument and accessories I established to perpetuate the original location of this corner: The bearing tree evidence found does not fit together very well. From the two stumps found I established the corner location. I set the cap at the mean location between these points which are about 3.5 ft. apart. It appears the distance to the S20 BT should have been 26 lks instead of 56 lks.

Set 2.5"x30" aluminum capped aluminum pipe rising 5" in mound of stones. Set steel fence post 3 ft. north of corner.

6.5" D. Fir bears N33 1/2°E, 38.7 ft., blazed & scribed: T6S R36E S17 BT.  
 10" D. Fir bears S2°E, 46.7 ft., blazed & scribed: T6S R36E S20 BT.  
 5" W. Fir bears S42 1/2°W, 19.9 ft., blazed & scribed: T6S R36E S19 BT.  
 10" D. Fir bears N52 1/2°W, 37.5 ft., blazed & scribed: T6S R36E S18 BT.

Painted blazes and attached signs as required in Specifications for Cadastral Surveys, USFS Region 6, March 1982. Attached 3/4" brass washer marked RLS 1848 to blazes.

Compass Declination: 19 1/2°E
