

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

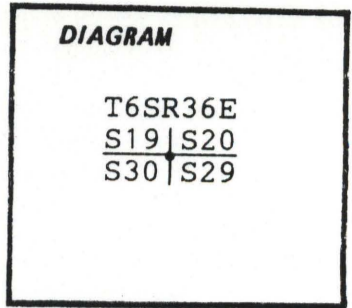

History of original corner establishment:

Original corner established in 1883 by William B. Barr under contract #492. Set a Pine post, 4"x4"x4', 24" in ground.

From which:

- A 18" Fir bears N75°E, 6 lks.
- An 8" Fir bears S45°E, 12 lks.
- A 12" Fir bears S40°W, 4 lks.
- A 48" Tamarack bears N45°W, 14 lks.



Description of corner evidence found:

Found no trace of original post.

Found the following original bearing trees:

- A 34½" Doug Fir (live, good condition), bears N75°E, 6 lks., open blaze healed over, did not open.
- An 8½" dead, down and decayed Fir bears S45°E, 12 lks., open blaze, faint scribing visible.
- An 18" White Fir (live, good condition) bears S40°W, 4 lks., blaze healed over, did not open.
- A 24½" dead standing Western Larch bears N45°W, 14 Lks., open blaze, full scribing visible.

Description of monument and accessories established to perpetuate the original location of this corner:

Cap is stamped:

At the position established from the orig. Bt's, I set a 2½"x30" aluminum capped aluminum pipe rising 4", no stones available

I set a steel fence post 3' North of corner

New BT's:

- A 6" Spruce bears S12°E, 29.7 ft., blazed&scribed: T6SR36ES29BT
- An 8" Spruce bears N19¼°W, 31.5 ft., blazed&scribed: T6SR36ES19BT

Painted blazes and attached signs as per Standard Specifications for Cadastral Surveys, USFS Region 6, March 1982. A ¾" brass disk stamped "RLS 1848" was nailed to the lower end of the blazes.

From Rd. 5178085 follow Rd. 5178 Southeasterly 0.5 Mile to a 6" Spruce on right with location poster. Corner is S45°E, 1400 ft. in the center of a draw flowing to the SE.
