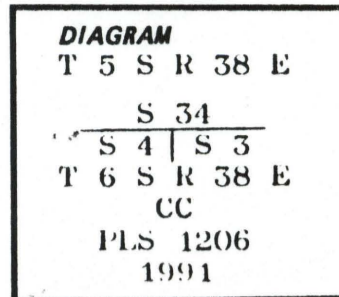


History of original corner establishment:

W. Barr surveyed the westerly portion of T. 6 S., R. 38 E., W.M. under contract No. 388 dated May 7, 1881.

Record states:

Set basalt rock 16 x 10 x 6 for closing corner to sec 3, 4 from which:
 Pine 12 in diam bears S 47 W 106 lks. dist.
 " 12 " " " S 22 E 100 " "



Description of corner evidence found:

Found stone 16" x 10" x 8" in ancient stone mound. Marked with one chisel mark on face. From which:

Rotted bearing tree remains bear S, 47° W., 70.0 feet dist. marked with a scribed "T".

Description of monument and accessories I established to perpetuate the original location of this corner:

From the original found Closing Corner stone location, projected the section line common to sections 3 and 4, northerly 1.14 feet to intersect the 1st Standard Parallel South. At this point set 1 1/4" x 30" galv. iron pipe 24" into the ground, constructed 36" dia. stone mound around the monument. 2 1/2" dia. brass cap is marked as shown in the corner diagram.

From which, new bearing trees:

- A 9" dia. Ponderosa Pine bears N. 9° E., 57.9 feet dist. marked T6S R38E S3 CC BT on double blaze.
- A 16" dia. Ponderosa Pine bears S. 27° E., 60.7 feet dist. marked T6S R38E S3 CC BT on double blaze.
- An 11" dia. Douglas Fir bears S. 78° W., 13.6 feet dist. marked T6S R38E S4 CC BT on double blaze.
- A 10" dia. Ponderosa Pine bears N. 48° W., 19.5 feet dist. marked T6S R38E S4 CC BT on double blaze.

Buried the original corner stone 1' north of the monument. Set fence post 2' west of the monument with USFS 54-9 sign attached. Also attached 54-9 and 54-3 signs to the new bearing trees.

I certify that the above corner was properly monumented under my direct supervision on August 28, 1991 as witnessed by Larry McBroom and David Smith.
