## History of original corner establishment:

A Pine 30 ins. in diameter bears N65°E, 30 lks. dist. marked T6SR38ES5 BT. A Pine 36 ins. in diameter bears S57°W, 44 lks dist. marked T6SR38ES7 BT. A Pine 40 ins. in diameter bears N77°W, 61 lks dist. marked T6SR38ES6 ET."

## Description of corner evidence found:

Found 12" X 10" X 5" basalt stone loosely set, marked with 5 notches on east and south edges form which a 36" pine stump bears N65°E, 19.8 ft. scribed BT. A 24" rotten pine bears S22°E, 45 ft., no scribing. A 40" pine stump bears N77°W, 40.6 ft. scribed BT.

Description of monument and accessories I established to perpetuate the original location of this corner:

At above described point set 21/2" X 30" galvanized pipe

and brass cap marked: Set pipe 24" in the ground and placed

a few rocks around. Placed marked stone at base.
