## Description of corner evidence found:

Found large Ponderosa Pine stump, size indeterminate, down, burnt and rotted bears N.17° E. 16.5 feet dist. No scribe visible.

17" dia Western Larch Stump 30" high with "BT" negative visible on the inside of the stump. The tree has been sawed off and is gone, stump bears south 28.4 feet dist.

# Description of monument and accessories I established to perpetuate the original location of this corner:

At the corner point as re-established from the remains of the two original bearing trees, set  $1\frac{1}{4}$ " x 30" galv. iron pipe 26" into gnd with  $2\frac{1}{2}$ " brass cap marked as shown in the corner diagram. No stone mound constructed. From which, new bearing trees:

A 13" dia Ponderosa Pine bears N. 86 E. 12.2 feet dist. marked 4 S4 BT on double blaze.

An 11"dia Western Larch bears N. 40 W. 28.6 feet dist. marked \$\frac{1}{4}\$ S4 BT on double blaze.

A 9" dia Western Larch bears S. 69 W. 17.4 feet dist. marked \$\frac{1}{4}\$ S9 BT on double blaze.

A 10" dia Ponderosa Pine bears S. 22 E. 36.5 feet dist marked \$\frac{1}{4}\$ S9 BT on double blaze.

Attached USFS 54-9 and 54-3 signs to all bearing trees. Set Fence Post 2 feet west of monument with 54-9 sign attached.

Note: Corner Point is located in an East-West running fence line of long standing.
