

At position established by Survey No. 012-2001 I set a 2 ½" x 30" copper clad monument in a water valve box, marked as shown below, 35" in the ground from which:

A 5/8" x 30" iron pin with 1 %" aluminum cap in a East-West fenceline bears N22°E, a distance of 50.93 feet, marked UNION COUNTY SURVEYOR NE RP.

A 5/8" x 30" iron pin with 1 %" aluminum cap in a East-West fenceline bears S21°E, a distance of 41.46 feet, marked UNION COUNTY SURVEYOR SE RP.

A 5/8" x 30" iron pin with 1 %" aluminum cap in a East-West fenceline bears S37°W, a distance of 35.19 feet, marked UNION COUNTY SURVEYOR SW RP.




