Found a stone 6"X 9"X 12" marked 1/4 from which: A 15" pine stump bears N 40 $^{\circ}$ E - 39.6 feet with visible axe marks.

At postion of the found stone:

Set a $2\frac{1}{2}$ " X 30" aluminum pipe with a $2\frac{1}{2}$ " aluminum cap, 24" in ground and surrounded with a mound of earth and stone. Deposited stone in hole along side of monument.

Attached sign 54-9 to steel fence post, set 3.5 feet North of monument.

New bearing trees established:
