

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

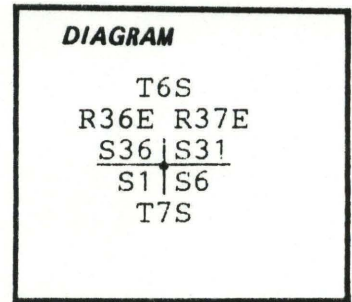

History of original corner establishment:

Original corner established in 1881 by Eugene P. McCornack under contract #398. Set post, 4"x4"x4½', 24" in ground.

From which:

- A 16" Pine bears N50°E, 20 Lks.
- A 9" Pine bears S50°E, 17 lks.
- A 14" Pine bears S55°W, 14 lks.
- A 16" Pine bears N15°W, 14 lks.



Description of corner evidence found:

Found no trace of post.

Found the following original bearing trees:

- A 12" dead & down, high stumped Pine bears N50°E, 20 Lks., full scribing visible.
- A 9" dead & down, high stumped pine bears S50°E, 14.2 feet. (Orig. distance 17 Lks.) full scribing visible.
- A 10" dead & down, high stumped Pine bears S55°W, 14 Lks. full scribing on under side.
- Decayed stump bears N15°W, 14 Lks., no marks.

Description of monument and accessories established to perpetuate the original location of this corner:

Cap is stamped:  
At the position established from the orig. BT's, I set a 2½"X30" aluminum capped aluminum pipe rising 5" in a mound of stones w/orig. stone along North side Set steel fencepost 3' North of corner.

- A 9½" Lodgepole Pine bears N38°E, 14.9 ft., blazed&scribed T6SR37ES31BT
- A 10½" Spruce bears S22¼°E, 44.6 ft., blazed&scribed T7SR37ES6BT
- A 10" Spruce bears S38½°W, 48.3 Ft. blazed&scribed T7SR36ES1BT
- A 10½" Spruce bears N55°W, 61.5 ft. blazed&scribed T6SR36ES36BT

Painted blazes and attached signs as per Standard specifications for Cadastral Surveys, USFS Region 6, March 1982. A ½" brass disk stamped "RLS 1848" was nailed to the lower end of the blazes.

3/10 mile southeasterly on Rd 4300 from Rd 5138, location poster on right, corner is 200 feet west on level ground.
