This Indenture, WITNESSETH, That Jane Riggs  
and a Widow his wife, for the consideration of

One Dollar and other valuable considerations Dollars  
to her paid, has bargained and sold, and by these presents do bargain, sell and convey

unto the County of Union, State of Oregon, the following described land for road purposes to-wit:

*A strip of land 40 feet wide, the same being 20 feet wide on each side of the following line*  
*which:* Beginning at a point which is West 30 feet from the center of Section

11 in Tp. 6 S. R. 38 E. of W. M. and running thence north 45<sup>o</sup> feet,  
thence N. 30 Deg. W. 205 feet, thence N. 53 deg. 30 min. W. 699 feet,  
thence N. 54 deg. 15 min. W. 501 feet, thence No 61 deg. W. 289<sup>1</sup>/<sub>2</sub> feet,  
thence N. 61 deg. 15 min. W. 198<sup>1</sup>/<sub>2</sub> feet, thence N. 61<sup>1</sup>/<sub>2</sub> deg. W. 201 feet,  
thence N. 61 deg. W. 201 feet, thence N. 64<sup>1</sup>/<sub>2</sub> deg. W. 197 feet, The lands
