

This Indenture, WITNESSETH, That *We - all and only heirs*  
of *James M. McCall deceased* his wife, for the consideration of  
*fifty and no/100* DOLLARS,

to them paid, have bargained and sold, and by these presents do bargain, sell and convey  
unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:  
A strip of land 60 ft. wide, being 30 ft. on each side of the center  
line of the Old Oregon trail Highway, La Grande-Hot Lake Section as  
surveyed over and across the N.E. 1/4 Section 26, Township 3, S. R.  
38, E. W. M. and more particularly described as follows:  
Beginning at the West boundary of the McCall estate at Station 214 by  
79 of the survey of the center line of said highway, which station  
is approximately 770 feet west of the corner for Sections 23, 24, 25,  
and 26, Township 3, S. R. 38, E. W. M. Running thence South 47 degrees  
59 East 14.9 feet, thence 15 degree curve right 207.0 feet, thence  
516 Degrees 57 minues E. 10.4 feet, thence on a 15 degree curve left  
102.7 feet to the east boundary of said property, containing .46 acres  
more or less.
