This Indenture, WITNESSETH, That A.A. Briggs

and Ollie Briggs his wife, for the consideration of One dollar  
and other valuable considerations DOLLARS,

to them paid, have bargained and sold, and by these presents do bargain, sell and convey  
unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

A strip of land sixty feet wide, being thirty feet on each side of  
the center line of the La Grande-Joseph Highway as surveyed over and across  
the S. E. 1/4 of Sec. 35 T. 2 N. R. 40 E. W. M. and more particularly  
described as follows:

Beginning at the intersection of the South boundary of the A. Briggs  
property and the La Grande-Joseph Highway, at Station 1734 of the survey  
of the center line of said Highway, which station is approximately 4.6 ft.  
N. and 400.0 feet West of the S. E. corner of Sec. 35 T. 2 N. R. 40  
E. W. M.; running thence N. 42 21' E. 479.5 ft., thence on an 8 degree  
curve left 130.5 ft. to an intersection with the East boundary of the A.  
Briggs property at station 1740 plus 10 of said survey, which station is  
approximately 458 ft. North of the S. E. corner of Sec. 35, T. 2 N. E. 40  
E. W. M., containing 0.51 acres more or less not included in the present  
road.

TO HAVE AND TO HOLD the said land, with its appurtenances, for county road purposes to said  
Union County and the public therein forever, and A.A. Briggs

and Ollie Briggs do hereby covenant to and with the said Union County
