This Indenture, WITNESSETH, That Florence M Elliott

and.....his wife, for the consideration of.....

..... DOLLARS,

to her paid, ha<sup>e</sup> bargained and sold, and by these presents do<sup>es</sup> bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

A strip of land Sixty feet wide, being thirty feet on each side of the center line of the LaGrande-Joseph Highway, as surveyed over and across the N. W. 1/4 of the N. W. 1/4 of Section 9 T. 1 N., R. 40 E. W. M., and more particularly described as follows:

Beginning at the N. W. corner of the Florence M. Eliot property at Station 1533 plus 38 of the survey of the center line of said road, which station is approximately at Section corner of Sections 4, 5, 8 and 9 T. 1 N. R. 40 E. W. M., running thence S. 89.18' E 118 ft. more or less along the North Boundary of said property to the point where the survey of the center line of said road curves away from the Florence M. Eliot property.

Reentering the Florence M. Eliot property at Station 1548 plus 70 of the survey of the center line of said road, which station is approximately 1266 ft. East of the corner of Sections 4, 5, 8, and 9, T. 1 N. R. 40 E. W. M. running thence S. 20.06' E. 132.3 ft. thence on a 6 degree curva left 78.7 ft. to an intersection with the East boundary of the Florence M. Eliot property at Station 1550 plus 81 of said survey, containing 0.17 acres, more or less, in addition to land already taken up by present road.

TO HAVE AND TO HOLD the said land, with its appurtenances, for county road purposes to said Union County and the public therein forever, and She, the said Florence M

Elliott do hereby covenant to and with the said Union County that.....the owner.. in fee simple of said lands; that they are free from all encumbrances except .....
