All the property of G. Klopfenstein located in the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$ , of Sec. 20, T. 2 S., R. 36 E., W. M., within a strip of land 60 feet wide being 30 feet on each side of the center line of the Old Oregon Trail Highway as now surveyed across said property, said center line survey being more particularly described as follows:

Beginning at a point on said center line survey known and designated as Sta. 311/90.1, said point being approximately 128.0 feet north and 1699.0 feet west of the one quarter section corner common to Sections 20 and 21, T. 2, S., R. 36 E., W. M., thence south 14 deg. 41' East 186.0 feet; thence on a 2 deg. curve to the left 216.7 feet; thence south 19 deg. 1' east 94.7 feet; thence on a 16 deg. curve to the left 239.6 feet; thence on a 11 deg. 50' curve left 131.0 feet; thence south 72 deg. 51' east 169.9 feet; to a point on the center line survey of said highway known and designated as Sta. 322/28.0, said point being approximately 633.0 feet south and 1137.0 feet west of the one quarter section corner common to Sections 20 and 21, T. 2 S., R. 36 E., W.
