All that part of the property of the P. E. Wade Estate in the $W\frac{1}{2}$ of
Section 16 T 1 S.R. 39 E.W.M., within a strip of land 70 feet wide, being
30 feet on the east side and 40 feet on the west side of the center line of
the La Grande-Joseph Highway, as surveyed and staked across said property,
said center line being more particularly described as follows:

Beginning at a point designated as Station 706 + 00, said point being
approximately 770 feet north of the section corner common to sections 16,
17, 20 and 21, T 1 S.R. 39 E.W.M.; thence north 26 degrees 49' east a
