THIS INDENTURE, WITNESSETH, That William C. Hill and Laura B. Hill
and _____ his wife, for the consideration of _____

One dollar and other valuable considerations _____ ~~DOLLARS~~,

to them paid, ha^ve bargained and sold, and by these presents do _____ bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property of W.C. Hill in the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 34, T. 1. N.R. 39 E.W.M. within a strip of land 60 feet wide, being 30 feet on each side of the center line of the La Grande-Joseph highway, as surveyed and staked across said property, said center line being more particularly described as follows;

Beginning at a point designated as station 874 / 00 of said center line survey, said point being approximately 20 feet south and 1392 feet east of the section corner common to sections 3 and 4, T. 1. S.R. 39 E.W.M. and sections 33 and 34, T. 1. N.R. 39 E.W.M. thence north 68 degrees 37' east a distance of 253.3 feet; thence on a 4 degree curve to the right a distance of 285.8 feet; thence north 80 degrees 03' east a distance of 1.2 feet; thence on a 6 degree curve to the left a distance of 324.2 feet; thence north 60 degrees 36' east a distance of 353.5 feet; thence on a 4 degree 30' curve to the left a distance of 277.2 feet to a point designated as station 1039 / 00 on said center line survey, said point being approximately 590 feet north and 2740 feet east of the above described section corner. Said parcel of land containing 1.71 acres more or less.

Now at this time is presented to the Court the deeds of Wm. C. Hill and wife and Sven Jansen and wife to rights-of-way across their land for the La Grande-joseph highway and it appearing to the Court that it is necessary for Union County to acquire the lands described in said deeds,

It is CONSIDERED and ORDERED that said deeds be accepted and the County Clerk is hereby authorized and directed to draw warrants on the Road Bond Fund of the County in favor of W. C. Hill and wife in the sum of \$2,000.00 and in favor of Sven Jansen and wife in the sum of \$224.00 in payment for said lands.

In the matter of the opening of the ballot boxes.

Now at this time upon application of the County Clerk, it is ORDERED that said Clerk be and he is hereby authorized and directed to open the ballot boxes and burn the ballots and stubs remaining therein from the last election and to prepare said boxes for use at the Primary Election to be held May 19th, 1922.

Now at this time it is ORDERED that the same Polling Places used at the last election be and the same are hereby designated as the Polling Places for the Primary Election to be held May 19th, 1922.

In the matter of the road petitioned for by John B. Scott, et al.

Now at this time it is ORDERED that the above entitled matter be and the same is hereby continued for the term.
