

TUESDAY, APRIL 12th, 1921.

In the matter of the acceptance of the deed of Arthur Gorham for a Road Right-of-Way.

Now at this time is presented to the Court the deed of Arthur Gorham to the following described property, to-wit: A strip of land 20 feet wide the South and West side of which is described as follows:--beginning at a point the South line of Section 16, Twp 6, S. R. 38, E.W.M. 414 feet, thence North 0 deg. 17 min. West 1000 feet, thence North 1 deg. 2 min West 320 feet to the Northwest corner to the Southwest quarter of the Southwest quarter Section 16, TWP 6 SR 38 E.W.M. all in Union County, Oregon.

It is therefore, CONSIDERED and ORDERED that said deed be and the same is hereby accepted and the landsdescribed therein be and the same are hereby declared to be a public highway of Union County.

In the matter of the acceptance of the Provisions of the Workmen's Compensation Act.

Thereupon it was ORDERED that Court be now adjourned until Tuesday, April 26th, 1921, at 9:00 o'clock A.M.
