and Mrs S. C. Johnston his wife, for the consideration of One Dollar
and other considerations DOLLARS,

to them paid, have bargained and sold, and by these presents does bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property outside of the land already dedicated to the public use or otherwise as a County Road, necessary to encompass a strip of land 30 ft wide adjacent and parallel to and on the right side of the center line of the Hunter Lane-Pleasant Grove Market Road as surveyed over and across the West side of the NE $\frac{1}{4}$ of Section 15 T 1 S, R 38 EWM; being more particularly described as follows:

Beginning at a point designated as station 621/76.0, said station being approximately 1650.0 ft. South and 17.5 ft East of the quarter corner between sections 10 and 15 T 1 S, R 38 EWM thence North a distance of 825.00 ft. to station 630/01.0, said station being approximately 825.0 ft. south and 17.5 ft. East of the quarter corner between sections 10 and 15 T 1 S, R 38 EWM.
