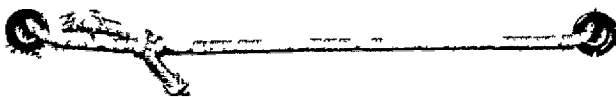

Bartmoss and William Gillman be and the same are hereby appointed viewers and W. B. Campbell surveyor, to meet at the house of Geo. Ackles on the 26th day of May A. D. 1878 at 10 o'clock and after being duly sworn proceed to view, survey and locate the above proposed road and to report to this Court at the next regular term thereof.
