

vince of Union began and held at  
the Court House in Union  
in said County on the 12<sup>th</sup> day  
of May A.D. 1850 and from  
day to day during the con-  
tinuance of said term,  
Present John A. Craig  
County Judge R. R. Holmes &  
W. G. Smith Co. Commissioners  
J. O. Swackhammer Sheriff and  
Willis Huff Clerk, the following  
Roads were created surveyed  
and the following named views  
appointed and the following  
times set for said surveys:  
to wit: County Road  
petitioned for by W. B. Gray et al  
commencing at the N.E. Cor. of  
Section 15. T. 2 South Range  
38 East, running thence south  
one fourth of a mile; thence  
East to the Ben Halley and  
Willow Creek County Road  
and to locate all other  
part of the County Road

commencing at the N. E. corner of Sec 15 T. 2. S. R. 38 East and running thence East one mile through the lands of Wm Gray. It was ordered that John A. Childers, J. R. Kellogg and Henry Myers be appointed viewers and Eugene Chase Surveyor to view survey, lay out and report upon said road and that they meet at the house of Wm Gray on the 25<sup>th</sup> day of May 1880 and after being duly sworn proceed upon their duties in this behalf. Also

County Road petitioned for by J. A. Wilson et al as follows, to wit: Commencing at the bridge at or near the house of James A. Wilson and to come Union Co Oregon and running thence North  $\frac{1}{4}$  mile thence West  $\frac{1}{2}$  mile intersecting the County Road  $\frac{3}{4}$  of mile from its starting point. It was ordered that M. B. Reese, W. B. May and A. R. Robinson be appointed viewers and Eugene Chase

Surveyor to view survey and lay  
out said road and report the  
same and that they meet at  
the house of James A. Wilson  
on the 24<sup>th</sup> day of May 1880  
and after ~~being~~ duly qualified  
proceed to their duties in this  
behalf. Also County Road  
petitioned for by Calvin Knapp  
as follows, to wit:

Commencing at the NW cor  
of the S $\frac{1}{2}$  of NW $\frac{1}{4}$  of sec 9 in T 2  
S. of R. 38 E. and from thence East  
one mile intersecting the  
County Road, said County Road  
running East one mile, thence  
commencing at the terminus of  
said road from thence East  
 $1\frac{1}{4}$  miles, thence South  $\frac{1}{4}$  of  
mile; thence East  $1\frac{1}{2}$  miles

East intersecting the Sumnerville  
and Union Town Road.






Survey of change of County Road in Pyle Canyon
