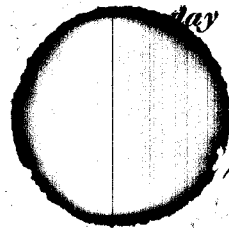

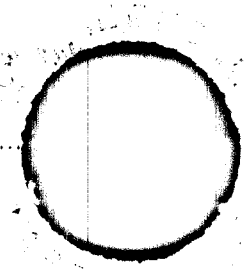

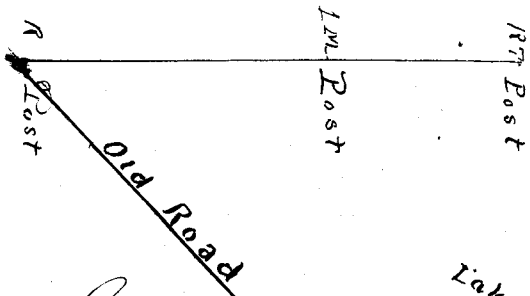

In the matter of proposed change of County Road leading from Lake House on Walla Walla Road to intersection with La Grande & Summerville Road

On this day, came Oliver Shafer, ^{by O. P. Bell esq.} who presents to the court the petition of himself and seventeen others, praying for a change in the location of the county road running from the lake house to intersect the road leading from La Grande to Summerville and which road is described as follows to wit: "Commencing at the Lake house on the Walla Walla Road, thence West 80.00 chs. set 1st angle post thence N. 48° W. 80.00 set 1st Mile post 26.50 set 2^d angle post, thence W. 80.00 set 2^d Mile post 80.00 set 3rd mile post, 80.00 set 4th Mile post 80.00 set 5th mile post 80.00 set 6th Mile post 80.00 set 7th mile post 43.50 chs. intersect Road leading from La Grande to Summerville" all in Multnomah County Oregon: as follows to wit: - Commencing at the 2nd angle post on said road and thence run in a due east course until it intersects the Walla Walla Road aforesaid, now known as the Hendershott Point and Summerville road, and to vacate the old portion of said road, the terminus of said proposed change being said 2nd angle post on said road and said

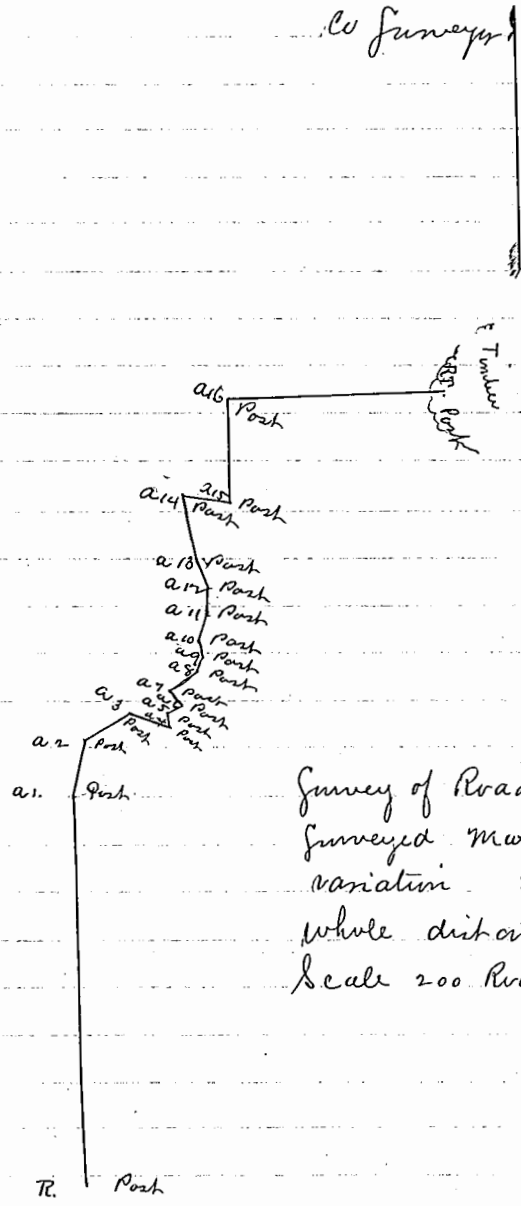
